At the 2011 Annual General Meeting, resolutions will be proposed to (among others) consider and approve (i) 2011 report of Board of Directors; (ii) 2011 report of Board of Supervisors; (iii) 2011 final financial accounts; (iv) 2011 profit distribution plan; (v) 2011 final emoluments distribution plan for Directors and Supervisors; (vi) budget of 2012 fixed assets investment; (vii) appointment of auditors for 2012; (viii) re-election of Mr. Chen Zuofu as Executive Director; (ix) election of Ms. Elaine La Roche as Independent Non-executive Director; (x) revisions to the Articles of Association; (xi) revisions to the Procedural Rules for the Shareholders' General Meeting; (xii) revisions to the Procedural Rules for the Board of Directors; and (xiii) revisions to the Procedural Rules for the Board of Supervisors. Among the above resolutions, resolution (x), (xi), (xii) and (xiii) will be and proposed as special resolutions, while other resolutions will be proposed as ordinary resolutions. The work report of independent Directors for the year 2011 is incorporated in this circular for your reference.

Resolutions of Board and Board of Supervisors

- On 16 December 2011, the Board considered and approved the resolution of budget of 2012 fixed assets investment and submitted it to Annual General Meeting for consideration.
- 2. On 23 March 2012, the Board considered and approved the resolutions of 2011 report of Board of Directors, 2011 final financial accounts, 2011 profit distribution plan, appointment of auditors for 2012, re-election of Mr. Chen Zuofu as Executive Director, election of Ms. Elaine La Roche as Independent Non-executive Director, and revisions to the corporate governance documents of the Bank including revisions to the Articles of Association, revisions to the Procedural Rules for the Shareholders' General Meeting and revisions to the Procedural Rules for the Board of Directors and submitted them to Annual General Meeting for consideration.
- 3. On 23 March 2012, the Board of Supervisors considered and approved the resolutions of 2011 report of Board of Supervisors and revisions to the Procedural Rules for the Board of Supervisors and submitted them to Annual General Meeting for consideration.
- 4. On 18 April 2012, the Bank circulated board meeting notice and proposals to the 15 Directors, and convened the board meeting by way of written resolutions. The Bank has received written responses from the 15 Directors. The convening of the board meeting and voting number of the Directors complied with the provisions of the Company Law of the People's Republic of China and the Articles of Association of the Bank. The proposals of 2011 final emoluments distribution plan for Directors and Supervisors and 2011 final emoluments distribution plan for Senior Management were considered and approved at the board meeting. Voting results of the proposals: voted in favour: 15 votes, voted

- 1. On the basis of the after-tax profit of the Bank for 2011 in the amount of RMB168.950 billion, 10% of such profit (being RMB16.895 billion) be appropriated to the statutory surplus reserve fund of the Bank;
- 2. RMB12.723 billion be set aside as general provisions for 2011;
- 3. On the basis of the after-tax profit of the Bank for 2011 in the amount of RMB168.950 billion, 35% of such profit (being RMB59.128 billion) be distributed to all the Shareholders (whose names appear on the shareholder register as of 21 June 2012) as cash dividend. The cash dividend per share hence would be RMB0.2365 (inclusive of taxes);
- 4. No transfer from the capital reserve fund will be made for 2011 to increase the share capital of the Bank.

Upon election at the 2012 first Extraordinary General Meeting and meeting of the Board of Directors and the approval of the China Banking Regulatory Commission ("CBRC"), Mr. Wang Hongzhang commenced his position as the chairman of the Board of Directors and executive director of the Bank from January 2012.

Upon the election at the 2010 Annual General Meeting of the Bank and the approval of CBRC, Mr. Dong Shi commenced his position as non-executive director of the Bank from September 2011.

Upon the conclusion of the 2010 Annual General Meeting of the Bank, Ms. Elaine La Roche ceased to serve as independent non-executive director of the Bank because of the expiry of her term of office.

From the second day of the 2010 Annual General Meeting of the Bank, Ms. Wang Shumin ceased to serve as non-executive director of the Bank because of personal job change.

From 11 October 2011, Ms. Sue Yang ceased to serve as non-executive director of the Bank because of personal reasons.

From 28 October 2011, Mr. Guo Shuqing ceased to serve as the chairman of the Board of Directors and executive director of the Bank because of the demand of the national financial affairs.

6. Changes of Supervisors

Upon election at the 2011 first Extraordinary General Meeting, Mr. Zhang Huajian commenced his position as the shareholder representative supervisor of the Bank.

BUDGET OF 2012 FIXED ASSETS INVESTMENT

The budget of 2012 fixed assets investment of the bank is RMB33 billion, focusing on supporting the business transformation, products innovation, physical networks and electronic banking channel construction, making sure the inputs in respect of resources for IT construction, business support center and fundamental projects, arranging appropriately the investment in the construction of integrated business property and other operating infrastructure while conducting reasonable control over investment on the automobiles, office equipment and other general fixed assets. Among the regular budget amounting to RMB27 billion, RMB12.5 billion will be used for the construction of business outlets, RMB2.3 billion will be used for the construction of electronic channels, RMB4 billion will be used for IT equipments and technological projects, RMB3.02 billion will be used for the construction of production infrastructure and its maintenance expenditure, RMB1.68 billion will be used for the improvement and renovation of integrated business buildings; a special budget of RMB6 billion will be used for the purchase of land and other upfront input for the comprehensive business buildings of head office and Beijing branch.

APPOINTMENT OF AUDITORS FOR 2012

The Board proposes that the Bank appoint PricewaterhouseCoopers Zhongtian Certified Public Accountants Co., Ltd. as the domestic accounting firm of the Bank and its major onshore subsidiaries for the year of 2012 and appoint PricewaterhouseCoopers as the international accounting firm of the Bank and its offshore subsidiaries for the year of 2012, commencing from the date on which this proposed resolution is adopted at the 2011 Annual General Meeting and ending on the date of the next annual general meeting. The audit expenses shall be RMB140 million (inclusive of internal control audit fee).

RE-ELECTION OF MR. CHEN ZUOFU AS EXECUTIVE DIRECTOR

The Board proposes to re-elect Mr. Chen Zuofu as Executive Director of the Bank. Mr. Chen meets the qualification requirements to serve as director as stipulated in relevant laws, regulations and the Articles of Association, the term of office shall be three years and will expire on the date of the 2014 annual general meeting. Mr. Chen's Curriculum Vitae is as follows:

Mr. Chen Zuofu, aged 57, a Chinese national, has served as a director of the Bank since July 2009 and executive vice president of the Bank since July 2005. Mr. Chen Zuofu was assistant president of the Bank from September 2004 to July 2005, and assistant president of China Construction Bank from July 1997 to September 2004. Mr. Chen Zuofu was a visiting scholar to Stanford University from June 1999 to May 2000. Mr. Chen Zuofu graduated from Southwest University of Politics and Law with a bachelor's degree in law in 1983. He received his master's degree in management and engineering from Central South University in 1996.

Remuneration of Mr. Chen Zuofu shall be determined with reference to *Interim Measures on Emoluments Distributions for Directors and Supervisors of China Construction Bank Corporation*. The Nomination and Compensation Committee shall, at the end of each year, propose the remuneration distribution plan and decide the amount of the remuneration, which shall be presented to the Board for consideration and be subject to implementation upon the approval of the Shareholders' meeting.

Besides the above stated, Mr. Chen has no relationship with the Bank's Directors, Supervisors, senior management, substantial Shareholders or controlling Shareholders and as at the date of this circular, Mr. Chen is not holding any equity interest in the Bank as defined in Section XV of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong), is not in possession of any information that is required to be disclosed by rule 13.51(2)(h) to rule 13.51(2)(v) of Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited, nor is he being involved or has been involved in any activity that shall be disclosed pursuant to rule 13.51(2)(h) to rule 13.51(2)(v) of Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited. Save as disclosed herein, Mr. Chen did not hold any directorships in other listed companies in the last three years or hold any positions in any members of the Group. There is no other issue that shall be brought to the attention of the Shareholders of the Bank.

ELECTION OF MS. ELAINE LA ROCHE AS INDEPENDENT NON-EXECUTIVE DIRECTOR

The Board proposes to elect Ms. Elaine La Roche as Independent Non-executive Director of the Bank. Ms. Elaine La Roche meets the qualification requirements to serve as director as stipulated in relevant laws, regulations and the Articles of Association, the term of office shall be three years and will expire on the date of the 2014 annual general meeting. Ms. Elaine La Roche's Curriculum Vitae is as follows:

Ms. Elaine La Roche, aged 62, a citizen of the United States, currently serves as a senior counsel in China International Capital Corporation Limited, and served as an independent non-executive director of the Bank from June 2005 to June 2011. Ms. Elaine La Roche had been the vice chairman of J.P. Morgan (China) Securities from 2008 to 2010. From 1978 to 2000, Ms. Elaine La Roche consecutively held several positions in Morgan Stanley. In 1998, she was seconded from Morgan Stanley to serve as the chief executive officer of China International Capital Corporation Limited. Thereafter, Ms. Elaine La Roche served as the chief executive officer of Salisbury Pharmacy Group, chief financial executive of Cantor Fitzgerald, and the chair of the board of Linktone, a NASDAQ listed company. Ms. Elaine La Roche graduated from Georgetown University School of Foreign Service with a bachelor's degree in international affairs and from the American University with a master's degree in business administration in finance.

Ms. Elaine La Roche's remuneration will be determined in accordance with the Measures on Administration of Allowance for Independent Directors and External Supervisors of China Construction Bank Corporation. The Nomination and Compensation Committee shall, at the end of each year, propose the remuneration distribution plan and decide the amount of the remuneration, which shall be presented to the Board for consideration and be subject to implementation upon the approval of the Shareholders' meeting.

REVISIONS TO THE ARTICLES OF ASSOCIATION OF THE BANK

Shareholders (in person or by proxy) attending this annual general meeting are responsible for their own transportation and accommodation expenses. Shareholders (or their proxies) attending this annual general meeting shall present identity certification.
